Based on data collected at ATT rollouts around the country and the feedback from Course Coordinators, the Steering Committee has recently revised the ATT examination verson 1. The new examination version 1.1 has been posted to the Course Coordinators Only section of www.ATTrauma.com. ATT Course Coordinators can choose between the original examination and the revised version in their upcoming courses. The Steering Committee is currently collecting data on the ATT Advanced version 2 exam and both versions of the Basic exam to determine the need for revisions.

ATT AT WORK IN AFGHANISTAN

ATT recently received this testimonial from a Lieutenant in the Swedish Army:

"You may be interested to know that two of my medics who took the ATT Course got their first hands-on medical experience 2 months ago, caring for five wounded Afghan soldiers.

A group of Afghan soldiers took a hit from an IED, which resulted in two minor injuries, one dead, one spinal injury with heavy pain in neck and back, and one critical patient who had double amputation to the legs. They put up a CCP (Casualty Collection Point) and treated the patients. They put tourniquets on the critical patient (one on each leg was enough), fenatyl lollipop 800, head to toe, IV (to keep vein open only). They called in the Blackhawks and Casevaced for the patients. Four of them survived. Both medics did a really good job and have been recognized for it. So it gives a really good re-enforcement that what we are teaching works, even in a combat environment.

As I am responsible for the medical training, I am getting a lot of good credit from the different commanding officers regarding this incident, which is really fun."

ATT APPROVED BY NREMT

The National Registry of EMTs has recently acknowledged that the ATT Course meets the 5 hours of mandatory and 1 hour of flexible content for the paramedic refresher trauma section. Students should remember that when completing the hour requirements worksheet for the re-registration, the ATT course has 8 hours that are classroom based while 2 are distributive learning.
